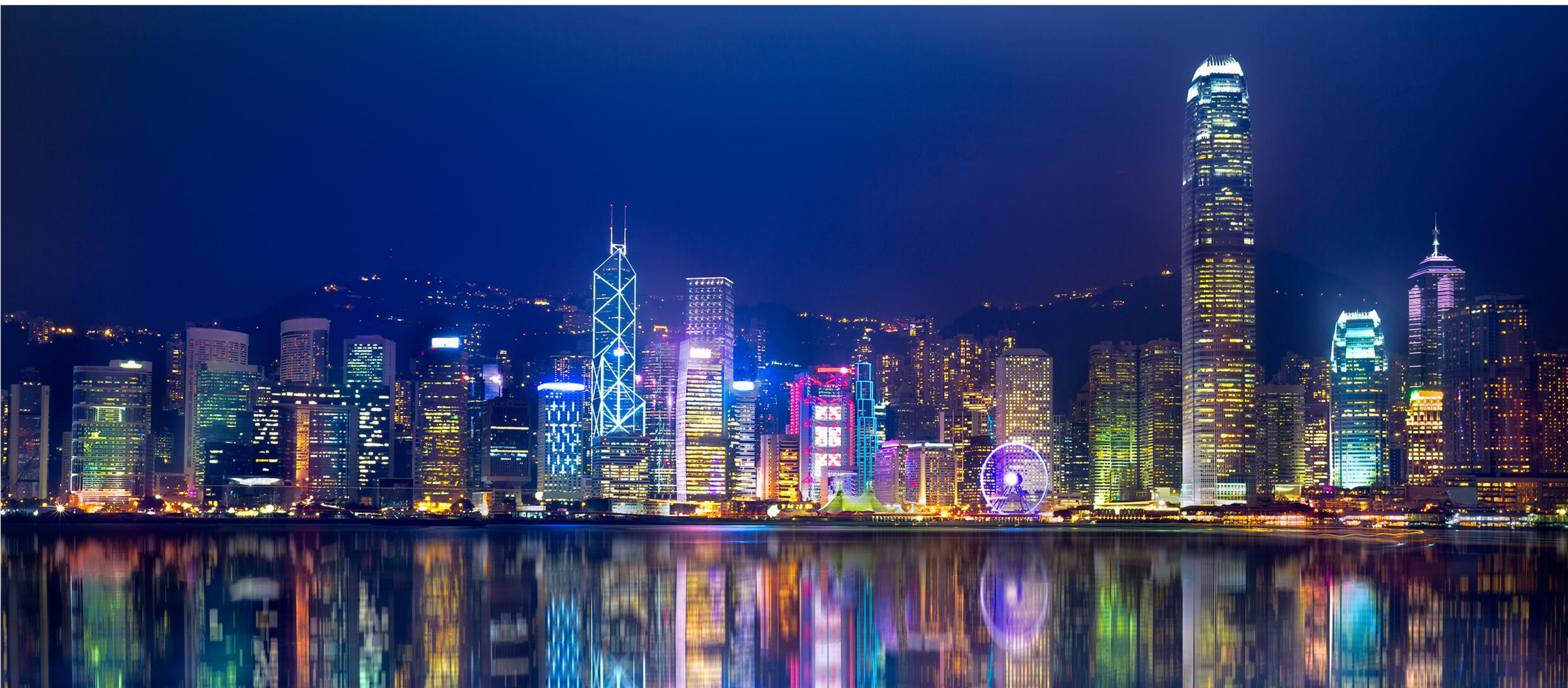

HKGX: Hong Kong Gold Exchange

The Hong Kong Gold Exchange aims to provide trading venue facilities and related services to bank members to engage in the trading of precious metals such as gold and silver. It is the only physical gold and silver exchange recognized by the Hong Kong Government. It is one of the few platforms in the world that still retains the open outcry trading form and an electronic trading platform.

The Hong Kong Gold Exchange, which has a history of more than 100 years, is the only exchange for physical gold and silver trading in Hong Kong. It was established in 1910. It implements a membership system and is managed by a board of directors and supervisors. There are currently 21 directors and supervisors. There are currently about 170 member companies, including banks, jewelers, gold wholesalers, gold minters and financial service institutions.
